

**INTERLOCAL AGREEMENT FOR SKATE PARK IMPROVEMENT FUNDING  
BETWEEN KITTITAS COUNTY AND THE CITY OF CLE ELUM**

WHEREAS, The City of Cle Elum has an established parks system that serves all citizens of Kittitas County; and

WHEREAS, included in the City of Cle Elum's parks system is a skate park located on land owned and maintained by the City in the 600 block of West Second Street in Cle Elum; and

WHEREAS, Kittitas County's participation in parks for the public includes assisting municipalities and service organizations in their maintenance of parks; and

WHEREAS, Kittitas County has available funding <sup>for</sup> in the amount of \$64,635.52 to assist in constructing improvements to the Cle Elum Skate Park; and

WHEREAS, the City of Cle Elum is willing to maintain the property and provide insurance coverage for operations at the Cle Elum Skate Park and manage funds necessary for construction of improvements thereto;

NOW THEREFORE, this Agreement is entered into between Kittitas County ("County") and the City of Cle Elum ("City") in consideration of the mutual benefits to be derived and the terms and conditions set forth below:

1. *Obligation of County Related to Improvements to Cle Elum Skate Park.* The county shall provide to the City of Cle Elum, funds in an amount not to exceed \$64,635.52 related to the improvements described in Exhibit A hereto, which funds shall be maintained by the City in a parks fund and disbursed for only those expenses documented to be in relation to Exhibit "A".
2. *Obligation of City Related to Improvements to Cle Elum Skate Park.* The City shall maintain the land and liability coverage for the Cle Elum Skate Park, and shall be directly responsible for the receipt into and disbursement from a parks fund in accordance with accepted state accounting standards, those funds to be received from the County as contributed for the Skate Park improvements referenced on Exhibit "A" hereto, and to provide the County, as requested, all documentation related to procurement, payment and installation of the Skate Park equipment referenced in Exhibit "A".
3. *Term of Agreement.* This Agreement shall run from date of execution to the date of completion of the improvements shown in Exhibit "A" hereto, but in no event to exceed a period of 12 months.
