Chapter 6 Ethics and Standards of Conduct:

- Councilmember Ratliff asked for discussion on 6.04, Conflicts of Interest and Appearance of Fairness, recommended keeping the first sentence of Chapter 6.04 and suggested deleting 6.03 and 6.02. Leave Chapter 6.04 as it is relevant to 6.02 and 6.03. the conflicts of interest and appearance of fairness laws. Should not add to what is already stated as the most complicated law.
- Councilmember Harper suggested it does not add to the adopted code of ethics but rather clarifies
 and defines the core values as a city. The minutes of the 12/06/2021 reflect council
 recommendation to consult the City Attorney regarding these chapters. Councilmember Harper
 stated he is in direct opposition of removing 6.03, leave 6.02 up for discussion. A breach of ethics
 clause (Chapter 6.03) would allow the council to take action in the case of an ethics violation.
- Gary Berndt recommended referring Chapters 6.02, 6.03 and 6.04 to the City Attorney and ask her for wording that would suit a small town.
- Council discussed what portions of Chapter 6 to send to the attorney.

- 6.02.1.a: Councilmember Ratliff stated he would vote against the entire Handbook because of the contents of Chapter 6.
- 33 6.02.2: Councilmember Harper stated this does not appear to have the potential for abuse.
- 34 Councilmember Ratliff objected to Chapter 6.02.2 due to the fact that it states whatever is rendered by
- 35 government should be affirmed by council and he disagrees. The council must make judicious
- 36 judgements.
- 37 6.02.3: Council discussed the clause "personal relationships" and questioned its purpose. Councilmember
- Lundh suggested removing "in all public and personal relationships" and end the sentence with "integrity".
- 39 Council agreed to this change.

- 8 councilmember, and it must be disclosed if there is an interest.
