- 1. <u>Call to Order & Roll Call</u> Meeting was called to order at 6:00 P/M/.with a quorum present. Chair Berndt, Commissioner Torrey, and Commissioner Kurtz Commissioner Fleugge was absent and approved.
- **2. Set Agenda** Chair Berndt asked for approval of the draft agenda. Agenda was approved as presented
- **3.** <u>Adoption of Minutes</u> The minutes from May 3 /2022 meeting were approved. There are no minutes from June or July as there was no quorum

4. Staff Report

- a. Chairman Berndt. The Chair reported attending interviews with 3 applicants for Planning Commission. It was also reported that currently with only 1 open position but there are also 2 open positions for "alternate" there was no interest in accepting an alternate. No decision was made as of this meeting date.
- b. Designated City Planner Gregg Dohrn. *Mr. Dohrn reported that on the request for training he would be willing to provide some options for training that he has presented to other entities. He inquired of the Commission having questions at this time. None were asked.*
