## 1. Call to Order & Roll Call

*Commissioner Berndt called the meeting to order at 6:04 p.m.* Commissioners present; *Gary Berndt (chair), Colin Brissey (zoom), Colonel Paul Kantwill, and Ian Steele\*. Matt Fluegge and Elizabeth Torrey both absent and excused.* 

\*Brief introduction and welcome of new Planning Commissioner, Ian Steele. Steele provided a brief overview of his professional background, as well as his connection to and interest in participating on the commission.

### Set Agenda

*Commissioner Kantwill motioned to update the set agenda to remove item 7c, Commissioner Steele seconded. Motion passed.* 

## 2. Adoption of Minutes

Commissioner Kantwill motioned to accept the minutes of February 15, 2023, as presented and with no corrections, Commissioner Brissey seconded. Motion passed.

## 3. Staff Report

a. Chairman Gregg Berndt, has drafted a letter to present to council regarding scheduling a meeting with council and the commissioners to discuss priorities.

#### 4. Citizen Comments on Non-Agenda Items (limited to 5 minutes)

Discussion of an email submitted to the Commissioners by M. Kirkpatrick regarding potential code amendments as they relate to side yard setbacks and zero lot lines.

#### 6. Unfinished Business

a. Wildfire Safety/Firewise, Berndt provided context regarding the Firewise document. Commissioner Kantwill proposed new language for commissioners to consider regarding Policy 9(a). After discussion, Commissioner Kantwill made a motion to update Policy 9 Item A to read, "A requirement that at least two means of effective ingress and egress for emergency vehicles in all seasons and weather conditions, as determined by local fire marshals, to include but not limited to load capacity, road grade and width, emergency vehicle turnaround, and street access shall be provided and maintained by project sponsors in areas where 30 or more residences exist or can be developed. I access road is blocked or is otherwise unusable for any reason, there shall be an alternate route for emergency vehicles to access and safely return to their stations, and for residents to escape. No new developments shall be approved that do not permit emergency vehicle access or the evacuation of residence under any circumstances." The motion was seconded by Commissioner Steele. Motion passed.

- b. Sewer Hook up rates have been put on hold, until Dohrn and Council can provide further direction.
- 7. <u>New Business</u> Questions from the Commissioners were asked, regarding where the review process for updates to Critical Areas is at.

## 3. <u>Staff Report</u>

- a. Chairman Gary Berndt, confirmed that on April 18, 2023, at 6 PM there will be a joint session with the City Council to discuss Planning Commission priorities. Priority topics would include Affordable Housing.
- b. Colleda Monick, noted that the Dept. of Ecology in January of 2023 issued a new SEPA checklist and the city has made the necessary provisions to update the existing checklist. She also provided a brief project update, including status reports regarding current planning projects.

Phil Hess, 4650 Airport Rd. Spoke regarding concerns related to future planning regarding the Upper County. He noted that it was imperative that the city and county planning should take a combined leadership approach in land use management. He recommended a joint master development plan.

Commissioner Torrey, requested information on a previous discussion related to this public comment, regarding where the city is at related to creating a *Kittitas County Cooperative* (noted as a possible discussion topic for the April 18<sup>th</sup> joint session?

He noted that, we are in a high fire risk community. This amendment should be kept as a living document and updated frequently. He expressed that this document was critically important to adopt.

Ingrid Vimont, Hospital District, reiterated Hess's earlier comments regarding coordinating our efforts with various agencies.

Rose Beaton, Doctoral Student studying wild fire and a DNR Resiliency Coordinator, commended the commission for taking an active approach. She noted support for better integration of language.

Department of Fish and Wildlife - written comment entered into the record.

Chair Berndt closed the public comment portion of the hearing.

Commissioner Torrey, requested additional time to evaluate and give due consideration to the comments we received.

The public meeting will remain open until April 18<sup>th</sup>, 2023.

Mayor McGowan reported 5 of 7 of the city council members were present, including Matthew Lundh, John Glondo, Steven Harper, Siw Bay-Hansen and Ken Ratliff. Sarah Lackey and Beth Williams were absent. The Pledge of Allegiance was recited. Other members present were Contract Planner Colleda Monick, and City Clerk Kathi Swanson.

A motion was made by Elizabeth Torrey and seconded by Paul Kantrell to approve the meeting agenda as presented. The motion carried unanimously.

#### **Planning Priority Discussion**

The Planning Commission has asked for clarification from city council on multiple projects, with the focus directed to the priority of the order in which to review and direct council.

• Councilmember Harper commented that many within the City believe it is a good idea to annex Suncadia into the city. New annexations must bring their own water and water storage. Developers will be required to provide this.

• Citizen Jeff Stubbs had asked the City to annex his property into the UGA, which borders the City of Cle Elum, but was told no by a former planner.

• Chairman Berndt read parts of a letter submitted by Kittitas County Department of Public Works, which comments the County is disappointed that the City has declined to consider traffic issues. Members of the council commented that they are not interested in a traffic mitigation tax or a transportation benefit district. Public safety is a higher priority than transportation. Grants are available for transportation.

• Council members asked the Planning Commission to look at the fees for low-income housing. The Planning Commission determined low-income housing should have lower monthly sewer rates. Councilmember Lundh recommended pursuing the possibility of lowering the hookup rate, but not the capital reimbursement charges. Further discussion will be required on this item.

• Members discussed the idea of updating the entire comprehensive plan rather than make simple code amendments.

• Chairman Berndt commented the numbering system of the current draft of the priorities list is good prioritization. Commissioner Fluegge asked to have the Master Plan added to the priorities List.

• Planning Commissioners would like to have information regarding Water and sewer availability. Mayor McGowan will provide that information to them.

• Recommendations to hire a full time planner as soon as possible.

• A suggestion was made by Matthew Lund to have the Planning Commission consider meeting twice per month.

• Councilmembers reported they have not had the draft list of priorities long enough to review and make recommendations. Councilmembers offered to have a discussion at their next regular meeting on April 24<sup>th</sup>, to discuss the priorities and bring back their recommendations at a future Special Meeting/Study Session. A red lined version of the discussion will be provided to the Planning Commission at a Special Meeting/Study Session scheduled for May 2, 2023 at 6:00 pm.
